As we all navigate our new normal in today's world, the Tennessee CASA network continues to advocate for Tennessee's children who have been abused and neglected. Tennessee CASA provides high quality training and technical assistance to the network while informing and improving the work of all involved in our state child welfare system. With the pivot to online trainings and seminars, we have exponentially expanded the educational opportunities for our advocates, staff members, and the community.

Although these times continue to be challenging, Tennessee CASA and the network of local programs have risen to the occasion and our impact continues to grow. In fiscal year 2022, 1,721 volunteers advocated for 5,258 children giving 130,388 hours of their time. This is a remarkable achievement in the face of the national struggle to meet the needs of child welfare agency staffing and foster family recruitment and retention. While we navigate these challenges, having a CASA volunteer for children in need is even more critical. To that end, Tennessee CASA is expanding into four new counties. Our goal is to continue the work until every county has a local CASA program.

Tennessee CASA would like to recognize the tireless work of our former board president, Matthew Muenzen. Matt was a member of the Tennessee CASA board for more than four years and served on our executive committee for three years. In addition to his board service, Matt provided invaluable support and training to our network. A new opportunity has taken him to Oregon where he will continue working in child welfare. In Matt's absence, I will serve out the remainder of his term as president-elect until our new board terms begin in January. Tennessee CASA is incredibly thankful for the effort he has given, and we wish him only the best in his future endeavors.

Once again, we would like to take this opportunity to celebrate the CASA staff, volunteers, and board members as well as all our child welfare partners. We look forward to continuing working together to expand our programs and safeguard children. Every child deserves a consistent caring adult in their life who will advocate for a safe and stable home.
